The Correspondent, **Manair Primary School (Nursery to V ) EM situated at H.No.2-59 , Padmanagar, Karimnagar** has submitted proposals for grant of Extension of Temporary Recognition classes Nursery to V(with one section) for the year 2023-2024 to 2027-2028 .

The Mandal Educational officer has verified the Proposals with reference to the conditions laid down in the Recognition orders and G.O Ms.No 1/Edn Date:-01.01.1994 and subsequent Government orders submitted a detailed report through the letter under reference 5<sup>th</sup> cited.

After careful examination of the proposals of the Correspondent and based on the recommendations of the Mandal Educational officer, Karimnagar ,the District Educational Officer, Karimnagar is pleased to accord post facto recognition for the academic year 20023-202224 and Extension of Temporary Recognition for Classes Nursery to V , EM for the year 2024-2025 to 2027-2028 in respect **Manair Primary School (Nursery to V ) EM situated at H.No.2-59, ,Padmanagar, Karimnagar** subject to the fulfillment of the following conditions.

1. The above permission is accorded purely on a temporary basis and is subjected to the reports of Sate Level Inspection and Vigilance committee fulfilling of all the Pre requisite condition under AP Education Act 1982 and if later found that, the school has not fulfilled any pre requisites as stipulated, the Renewal Recognition now being given is liable to be withdrawn at any time.
2. That the society shall abide to the rules and regulations made in the Government orders 1<sup>st</sup> cited and subsequent orders. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, furniture ,library ,Laboratory, equipment play feld required staff as per the staff pattern another facilities.
4. That the Permission is accorded to the Manair educational society Regd No.5010/1997
5. The Permission is accorded to run the school in the locality and there shall not be any change in the premises of locality specified in the orders.
6. The Management should follow the G.O Ms.No. 22 Date:-18.07.2017 i.e., regarding weight of the School bag.
7. That the administrative report and the audited statement of accounts of the school duly attested by the Chartered accountant for every financial year shall be submitted to the District Educational officer, latest by September
8. The Management has to follow the Government norms from time to time ,for collection of fee from students.
9. The Educational Society shall not use the premises building ,play ground and vacant site belongs to the institution for any purpose other than the Educational activities and conducting authorized examinations without permission of the District Educational officer
10. The Management should follow the guidelines issued in G.O.Ms No. 36 School Education (General) Dept dt:-16.12.2017 for the safety and security of the children in the schools.
11. The Management should pay the mandate taxes due to the concerned departments as per schedule fixed by the Government.
12. The school Shall follow the traffic and safety guidelines indicated by the police and fire services department
13. The School Shall have "first aid-Kt and the teachers shall be trained in first aid.
14. That any children studies in recognized school of other state/countries affiliated to the bodies recognized by the state of central government shall not be admitted without prior permission of the District Educational officer/Director of School Education.
15. That the management shall not collect any fees or donations either in cash or kind other than the fees prescribed by the governing body from pupils or parents or any other person or on their behalf for any purpose.
16. That educational agency shall not force any member of the staff or students of the institutions to take part in the religious discourses and preaching of religion irrespective of whether they belong to the same belief or not.
17. If the Management provides transportation ,it is the responsibility of the Management to submit fitness certificates of their buses every year regularly to the District Educational officer to have

skilled, Trained ,licensed and healthy driver. If any deviation in the matter, they will be personally held responsible.

19. The Correspondent should submit renewal of Recognition proposals before 90 days of the expiry of Renewal Recognition.
20. The Educational Agency should implement the Model Education code prepare by National university for educational planning and Admiration in 2015.
21. That the Educational agency shall not permit the students of any DEd/Bed college or college of Physical Education or any teacher training institution to have teaching practice without the permission of the District Educational officer
22. Proper and adequate parking area for vehicles shall be provided transporting the children to and from the school.
23. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
24. The parents Teachers associations meeting shall be conducted to sensitize the Parents on the safety of the children.
25. The school Shall constitute committees for redressal of the Public/Staff/Parents/Students grievances, Internal Complaints committee on sexual Harassment and committees under POSCL (Protection of Children from Sexual offence ) Act 2012 and details of these committees along with contact details shall be displayed prominently on school notice board and conspicuously on the school website for the information of all the stakeholders.
26. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
27. The School timing, Vocational and mid-term Holidays shall be followed pre-scribed by the Government from time to time.
28. As per the staffing pattern the qualified staff within the age limits prescribed by the Government for Government Employees shall be appointed.
29. Appointment of Teaching and Non-Teaching Staff within the age limits prescribed by the Government for Government Employees shall be appointed.
30. That the governing body/Staff selection committee shall be furnished to the District Educational Officer every year.
31. The approval of the correspondent ship should be get approved by the competent authority.
32. That the pay structure/fee structure fixed by the governing body shall be get approved by the District Educational Officer every year.
33. That the school shall not be closed without giving prior notice both to the parents/District Educational Officer and to the competent authority concerned at least 6 months before.
34. Next higher classes additional sections should not be opened with-out prior permission from the competent authority.
35. That all Condition prescribed in G.O.Ms.No. 1 Dt. 1-1-1994 & G.O.Ms.No. 41 Dt. 11-5-2006 and other orders issued by the Government time to time. Which are not specified in this proceeding shall be completed with.
36. The Correspondent is informed that the Institution as founded /Permitted by Department as per chapter(1) Section 2 of RTI Act 2005.The management should abide the rules of RTI Act 2005.

The Correspondent is requested to submit compliance report on fulfillment of conditions prescribed, within three months through Inspecting officer concerned without fail. The receipt of the proceedings shall be acknowledged.

- 1 That the Educational Society shall abide by the instructions/rules issued by the Govt. from time to time
- 2 That the Educational Society shall serve the needs of locality more particularly.
- 3 That the institution shall adopt the curriculum and syllabus prescribed from time to time by the State Government.
- 4 That the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
- 5 That the qualified staff within age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern as per G.O Ms.No. 103 Edn (PS), dt.05-08-2005.
- 6 That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn. (PS), dt.26.02.98.
- 7 That the records/accounts shall be furnished to the D.E.O every year by 31<sup>st</sup> March, at the latest
- 8 That the list of governing body shall be furnished to the DEO every year.
- 9 That the pay structure / fee structure fixed by the governing body shall be got approved by the DEO every year.
- 10 That all the conditions prescribed in G.Os and other orders which are not specified in this order shall complied with.

- 11 That the school shall not be closed without giving notice both the Parents/DEO and competent authority at least (6) months before.
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the Educational Society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
- 14 That additional sections/higher classes should not be opened without prior permission of the competent authority.
- 15 That the recognition is accorded to Educational Society and no other society or body can open a school on their behalf.
- 16 The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
- 17 The Educational Society shall provide, the necessary material even if it costs more than the deposit amount.
- 18 Admissions should be made on the basis Record sheet issued by the Private Recognized /ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bona-fied candidate
- 19 The Educational Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.6<sup>th</sup> cited.
- 20 The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P. Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once
- 21 The Management shall provide sufficient transportation, sufficient fire extinguishers in the school. The management will be personally responsible to get update No Objection Certificate from the authorities concerned.
- 22 The Management is totally responsible in all aspects for the safety of school children. They will be personally held responsible if any incident occurs.
- 23 The Management shall handover the school premises whenever required to this department /Government for emergency purpose (Exams/ Elections etc.,) without any deviation of the orders.
- 24 If the Management provides transportation, it is the responsibility of the Management to submit Fitness Certificates of their buses every year regularly to the D.E.O. and to have skilled, Trained, Licensed and healthy driver. If any deviation in this matter, they will be personally held responsible.
- 25 The management will be personally held responsible to get up to date certificates from the Departments/Agencies concerned, wherever is necessary in the interest of the School students/parents.
- 26 The sanitary certificate to be submitted every year to District Educational Officer concerned from Panchayat Secretary (Competent authority).

The District Educational Officer is requested to watch the above instructions at the time of visit / inspection.
